## Antitrust



The lawyers that are part of this team know in detail the national and regional antitrust regulations. They pay special attention to regulatory updates from the United States and European Union, as these jurisdictions reflect the tendencies that may impact in changes of local regulation and affect our clients' activities.

The antitrust team has experienced lawyers that analyze and determine whether there is an obligation to submit economic concentrations for approval in diverse industries such as telecommunications, pharmaceuticals, construction companies, mass consumption products, automotive, etc.

These professionals thoroughly analyze the best strategies in order to advice our clients for a cost-effective and quick submission, aligned with the authorities' guidelines, precedents and regulations.

The definition of the relevant market is essential, and our team knows it: they daily analyze how the National Antitrust Commission (CNDC) analyses relevant markets in its resolutions.



Our lawyers follow up very closely each of our clients operations and answer all necessary information requests until the operations are finally approved by the CNDC.

Our team is also in charge of advising clients in cases of anticompetitive conducts (both as complainant or as alleged infringers) and walk with them through the process of market investigations filed by the CNDC, that may trigger an ulterior administrative procedure for anticompetitive conducts of the actors of each analyzed market. In that sense, out firm has advised in several of the most resonant investigations and conducts of the last few years.

Their guidance in matters of economic concentrations and anticompetitive conducts not only reaches the administrative procedure, but also includes the advice before judicial courts, for the adequate defense of our clients' interests up to the last possible instance.
